These services are perfect for anyone wishing to get a vehicle abroad without decreasing its value. Since shipping a vehicle abroad takes some preparation, it is highly suggested that anyone who plans an overseas transport create a checklist. A checklist is always helpful in any type of relocation situation. There is so much that will need to be addressed for an international transport that it can often get confusing. Here Is What Your Checklist Should Include:

- Search for reputable international transport companies. Call for quotes and book with one at least two months before the desired shipping date.
- Call the Embassy of the country you wish to ship the vehicle to. Write down all of the requirements and make sure that you are fully aware of the nation's auto import policy.
- Begin preparing all proof that must be provided to the Customs Department. Of course, your transport professionals will also be knowledgeable of dealing with strict import laws and will help you fulfill all of the requirements.
- Clean the vehicle and prepare it as requested by the shipping company. This is usually a fairly simple process that only takes a little time to complete.

- Inspect your vehicle and write down any damages you are aware of before you allow it into the hands of the transporter. Take photographs of the automobile as well. You can use your notes and pictures to conduct your final inspection of the vehicle after you retrieve it from the port it is delivered to.
- Make sure you have a ride arranged to and from the ports and terminals if necessary. A port will not hold a vehicle for anyone, so it is important that you are present on the day of its arrival.

Your checklist can be as detailed as you would like. The above is a simple but effective guideline that will help you stay on top of matters. You will find that the transport company is extremely helpful with this as well.

About International Auto Import Policies

All countries have the right to set their own auto import policies. While some countries are more lenient with their restrictions, others can be very strict. Any international transporter with experience will be understanding of such import laws and even know of loopholes and other ways to address the import policy of the country you wish to send your vehicle to. Transporters also have access to resources that most others do not, which could really help your situation if the country you are shipping to makes it difficult to comply with their import laws.

Not only will your vehicle need to meet the country's vehicle specifications, but it will be required to undergo inspection. As the owner of the vehicle, you will be expected to pay duties and tariffs. Be fully prepared to pay such taxes. They often cost more than the delivery services and can be as high as 100% of the vehicle's estimated value. Proof that the taxes were paid must be presented to Customs along with all of the other documents demanded.

If you and the transport company gather all of the pertinent documents and fulfill all of the rules of the country's import policy, then gaining access into the country shouldn't be difficult. Customs will release a certification of approval for the vehicle if everything they asked for was presented to them. This approval allows the vehicle into the country. Without it, the vehicle will be denied lawful access.
